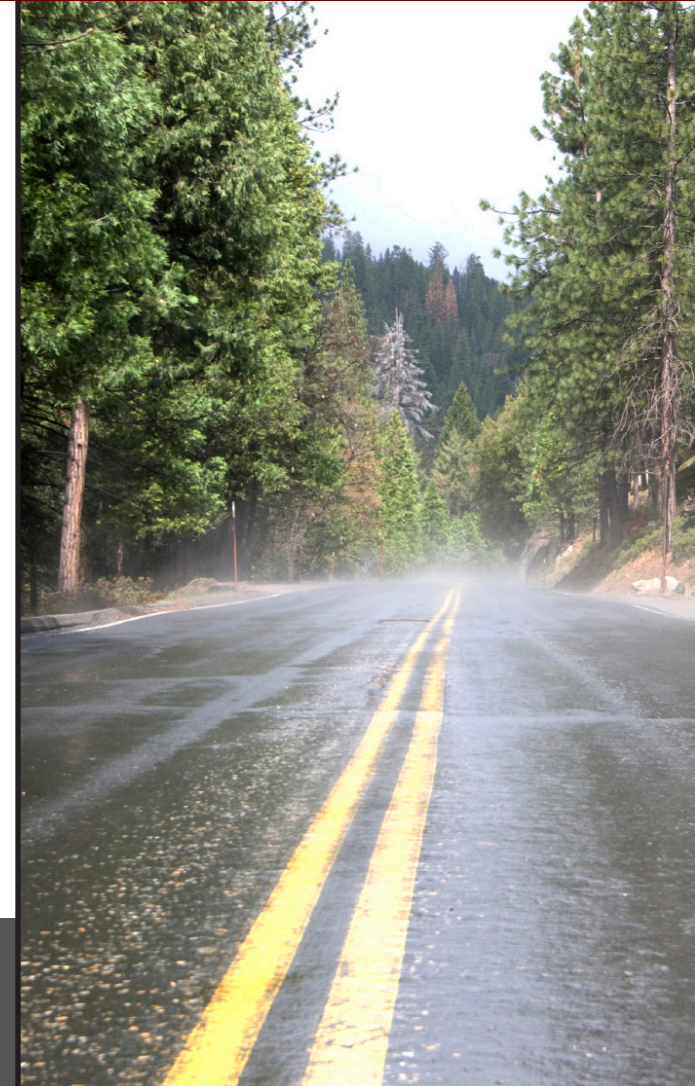

## Presenters

He assists the LAP with environmental reviews to ensure projects are meeting the environmental standards/considerations set forth under NEPA. Costa holds a bachelor's degree in Urban Planning and Design and a Master's Certification in Geomatics from Eastern Michigan University.

**Lynnette Firman**, PE, Lynnette M. Firman, PE, is the urban project development engineer for the Michigan Department of Transportation (MDOT) Local Agency Programs (LAP), a position she began in 2015. In this role, Firman works with the environmental and funding aspects of local agency projects. Firman's MDOT career began in 2007 in the Traffic Safety area, and she rotated through various units before permanently working in Pavement Markings. She moved to the LAP as its safety engineer in 2012. Firman is a 2002 graduate of Michigan Technological University and holds a bachelor's degree in Civil Engineering.

**Mark Harrison**, PE, is the project development engineer for the Michigan Department of Transportation Rural and Bridge units. He has been with MDOT for 23 years and with MDOT's Local Agency Program for 16 years. Currently, Harrison's primary duties include project funding, programming, and environmental compliance. Prior to joining MDOT's Local Agency Program, he worked in the Bridge Design section. Harrison graduated from California State University, Sacramento, in 1994 with a bachelor's degree in Civil Engineering, and he is licensed professional engineer in Michigan.
