### **Bid Price Structure**

- I. Bid to be based on the cost of plowing one complete time (cycle) including intersection clearing.
- 2. The contractor shall submit an invoice to the Road Commission in order to be paid. Invoices must show each cycle plowed, date of service, and unit cost.
- 3. The Road Commission approves bills every two weeks. It is the responsibility of the contractor to provide the invoice in a timely manner in order to be paid.
- 4. Each route will be awarded in the best interest of the Road Commission.
- 5. Prices to remain firm throughout contract period.

### Areas to be Bid

The Emmet County Road Commission is bidding out the snowplowing services of 9 different routes in the county plus seeking a bid for possible mainline snowplowing services. The following names of the routes are to be used under this contract. Attached are the individual roads and accompanying maps for each bid area.

1. Pleasantview Route: Mileage – 6.64 miles

2. Harbor Route: Mileage – 2.31 miles

3. Bear Creek Route: Mileage – 3.26 miles

4. Bay View Route: Mileage – 1.79 miles

5. Resort South Route: Mileage – 3.26 miles

6. Resort North Route: Mileage – 3.29 miles

7. Oden Route: Mileage – 3.52 miles

8. Conway Route: Mileage – 3.84 miles

9. N. US 31 Route: Mileage – 1.41 miles

10. <u>Mainline Paving</u>: The road commission is seeking information and bids on the ability of the contractor to perform mainline snowplowing on roads including US 31, US 131, M-119, M-68, primary roads, and local roads. This information is being sought in case the need arises where the Road Commission is unable to perform the work in an emergency situation.


