- Beginning January 2017:
 - \$410 million in additional fuel tax revenues
 - Tax on gasoline and diesel fuel rises to \$0.263 (provides for diesel parity)
 - 20% increase in vehicle registration fees
 (~ \$190 million)
- General Funds transferred to transportation and distributed through three way Act 51 formula for road agencies:
 - 2019: \$150 million
 - 2020: \$325 million
 - 2021: \$600 million
- Beginning in 2022, fuel tax will be indexed, rising in proportion to increases in Consumer Price Index, or 5%, whichever is less.


MTF Revenue Divided 697 Ways

WARRANTY PROVISIONS

- PA 175 of 2015 Warranty Requirements
- Requires MDOT and locals to use warranties
- Submit program to MDOT for approval
 - Reconstruction and new road construction projects
 - Projects over \$2 Million
- Must implement within one year of MDOT approval
- MDOT/Locals must submit detailed reports on existing warranty projects each year



WARRANTY PROVISIONS

- Local warranty guidelines are being developed to include:
 - Performance Metrics
 - Type of projects/length of warranty
 - Administration and reporting requirements
- Additional meetings planning
- Work to be completed by May 2017

ROADS INNOVATION TASK FORCE (RITF)

- Required formation of internal task force
 - Met with Transportation Partners in December 2015
 - Solicited input from national experts, academia, FHWA
- Evaluate arterials with goal of roads lasting 50 years
- Materials may cost more but produce longer life
- Report submitted on March 1, 2016
- MDOT to present to Joint Committee of House and Senate
- Update and finalize by June 1, 2016
