#### LAP Scorecard – FY 2013

Status Report through February 2013 MDOT letting

- 111 proposals let, totaling 136 individual projects
- \$ 77,887.236 total
- Approximately 9.4 % below the engineer's estimate

## Force Account Projects

#### Limitations still in effect

lesser of 5 projects or \$400,000 per fiscal year

TSC's have construction oversight responsibility

LAP Staff Engineer needs final plans, special provisions, both cost estimates, all in electronic format

Allows TSC Operation Engineer access to the final plans, similar to contracted projects

### Force Account Projects

#### LAP Staff Engineer Role changes:

still issues force account authorization (LARS) still approves requests for reimbursement still reviews reimbursement requests for compliance with requirements (ie local agency overhead cost, Buy America)

LAP Staff Engineer needs final Form 1120 (Certification of Final Inspection), completed, before approving final reimbursement request

#### **Alternate Pipe Material Policy**

Originally mandated by SAFETEA – LU

CRAM, MML, and MDOT developed the Local Agency policy in 2008

Opportunity to revisit the policy (MAP-21)
