Projects having federal aid must be let through the MDOT letting system

HOW IT WORKS

Projects selected and announced by legislature, December 2013

Local agency completes 1 page program application and Request for Payment, and forwards to MDOT LAP (Larry Doyle)

MDOT prepares the cost sharing agreement, forwards to Local Agency for signature and return to MDOT

MDOT forwards payment to Local Agency

Construction complete and project close out deadline December 2015

Roads & Risks Reserve Program

Local Agency

- Prepares bid proposal package
- Advertises for bids, award contracts locally
- Completes construction and certifies to MDOT

Roads & Risks Reserve Program

- After construction, complete the certification form and forward to MDOT LAP (Larry Doyle)
- All projects subject to final audit
- Only the approved project is to be constructed
- Cost overages responsibility of Local Agency
- Final costs less than awarded amount reimbursed by Local Agency

2015 Safety Program Update

- Proposed projects are currently being scored Scoring committee final meeting by early March
- Agencies will be notified by April 1st
- HSM Spreadsheet recently updated on LAP website, to include a background calculation fix

QUALITY OF SUBMITTALS

- → Local Agency is responsible for QC / QA of plans, special provisions, construction cost estimates, permits, SHPO letter
- → Recent submittals have been incomplete, scattered
- → Don't submit an incomplete package just to meet a deadline
- → Address the permit requirements
- → Sometimes obvious that minimal QC was completed
- → Don't submit ANYTHING until you have EVERYTHING

SECTION 106 REVIEWS

- Contact the area Native American Tribal Government
- Contact is required as part of Section 106
- Contact is NOT MADE by SHPO, and NOT included in the SHPO letter
- Link to Tribal Government contact information is on LAP website
